1. Typically the only way you can get three year extension is if you can prove that the project will go on for three years.
2. Typically a client letter.
3. Make sure your social media is not in any way in contravention or opposition to what you have been saying to the government.
4. Once you get married you are entitled to cross chargeability and you can be charged under Nepals category which is available right now. As soon as you get married you should have

your lawyers write to the government and ask for cross chargeability. Probably within a few months you could be scheduled for an interview, which again depends upon how busy the local office is. [More...](#) [2]
