## Green Card (Immigrant Visa)

**Note: The filing fee of \$1225 includes fee for applications I-485, I-765, and I-131, and fingerprinting irrespective of whether I-765 and I-131 applications are submitted along with I-485.**

### **Non-Routine Services**
