On Feb. 23, 2014, [E-Verify](#) [2] released an updated Department of Homeland Security (DHS) Tentative Nonconfirmation (TNC) Further Action Notice to include information on correcting immigration records. The Further Action Notice directs employees to the Fact Sheet: [How to Correct Your Immigration Records after Resolving a Tentative Nonconfirmation in E-Verify](#)[3] for more detailed instructions.
